

INSTRUMENT OF DELEGATION

Ombudsman Act 1976

Australian Federal Police Act 1979

I, Richard Glenn, Acting Commonwealth Ombudsman,

1. Under subsections 34(1), 34(2), 34(2A), 34(2B) and 34(2C) of the *Ombudsman Act 1976* (the Act), **revoke** all previous delegations issued under the Act and **delegate** to any person from time to time holding, occupying or performing the duties of a position in the Office of the Commonwealth Ombudsman specified in Column 1 of the Schedule to this Instrument, the powers conferred on me by the provisions of the Act specified in the corresponding part of Column 2 of the Schedule to this Instrument; and
