It could be a PID, what do I do?

Authorised officers, as the main gatekeepers for internal public interest disclosures (PIDs), have an important role in recognising the different types of misconduct arising in PID matters, and where or to whom within an organisation it is most appropriate to allocate those matters for investigation.

There are a range of considerations for authorised officers in the discharge of these responsibilities, and caution must be exercised to ensure that their role is not confused with the role of a PID investigator.


