

ASSESSMENTS BY THE COMMONWEALTH OMBUDSMAN FOR TABLING IN PARLIAMENT

Under s 486O of the Migration Act 1958

These are s 486O assessments for 10 detainees who remained in immigration detention for more than 24 months (two years). The following detainees were released from immigration detention after being granted bridging visas.

The Ombudsman assessed information provided by the Department of Home Affairs for each of these individuals and identified no concerns regarding their detention circumstances since the Ombudsman's previous assessment.

Prior to their release from immigration detention, each individual remained in immigration detention in the manner indicated in their previous Ombudsman assessment.
