Recent detention history

Since the Ombudsman's previous report (1003419), Mr X remained at Maribyrnong Immigration Detention Centre (IDC).		
23 July 2016	Transferred to Villawood IDC.	
September 2016	Mr X was released from detention when he voluntarily departed Australia and returned to Country A.	

Recent visa applications/case progression

The Department of Immigration and Border Protection (DIBP) advised that its 30-month review, dated 10 March 2016, incorrectly advised that Mr X lodged a Temporary Protection visa application on 4 December 2015. DIBP confirmed that Mr X instead lodged a Safe Haven Enterprise visa (SHEV) application.

23 March 2016	Mr X withdrew his SHEV application and requested removal from Australia. He withdrew his request on 14 April 2016.
2 May 2016	Lodged a second SHEV application.
12 July 2016	Mr X withdrew his second SHEV application and requested removal from Australia.
August 2016	The Country A Embassy issued Mr X with a travel document.
September 2016	Mr X voluntarily departed Australia.

Criminal history

8 June 2016	Mr X breached his three-month good behaviour bond after being
	charged with damaging property, animal cruelty and two counts of
	behaving in an abusive manner.

11 August 2016	Mr X was found guilty of two charges of threatening to kill and one
	charge of animal cruelty with no conviction recorded. He was issued
	with a four-month good behaviour bond.

Health and welfare

International Health and Medical Services advised that Mr X was monitored by the mental health team following behavioural issues and incidents of self-harm. He attended a psychiatric review on 13 June 2016 and no evidence of significant mental illness was identified.		
5 May 2016 and 10 August 2016	DIBP Incident Reports recorded that Mr X self-harmed.	
7 August 2016 – 27 August 2016	DIBP Incident Reports recorded that Mr X threatened self-harm on five occasions.	

Recent detention incidents

DIBP Incident Reports recorded that Mr X was involved in multiple behavioural incidents and displayed abusive and aggressive behaviour towards detention centre staff.

Case status

Mr X voluntarily departed Australia in September 2016 and returned to Country A.
