# General Comments

I note the 154 Commonwealth Ombudsman's assessments tabled in Parliament on 13 February 2008 and take this opportunity to express my serious concern that so many detention cases have taken so long to resolve.

I note that 12 of the individuals referred to in Commonwealth Ombudsman's statement remain in immigration detention. I note that an additional 61 people currently in immigration detention have been detained for longer than two years.

I have requested advice from my department as to how these current long term detention cases may be resolved quickly, and options and mechanisms for a strategic approach to reducing both the number of people in detention and the time that people spend in detention.
