

**REPORT (ABRIDGED) BY THE COMMONWEALTH AND
IMMIGRATION OMBUDSMAN FOR TABLING IN PARLIAMENT**

This is the first s 486O report on Mr X who remained in restricted immigration detention for a cumulative period of more than 24 months (two years).

Detention history

11 April 2012	Detained under s 189(3) of the <i>Migration Act 1958</i> after arriving in Australia aboard Suspected Illegal Entry Vessel 317 <i>Steele</i> .
13 September 2012	Granted a Bridging visa and released from restricted detention.
30 September 2014	Re-detained under s 189(1) on expiry of Bridging visa.
19 October 2016	Granted a Bridging visa and released from restricted detention.

Visa applications/case progression

The Department of Immigration and Border Protection (the department) advised that Mr X has been found not to be owed protection under the Refugee Convention and the complementary protection criterion. Mr X has no outstanding matters before the department, courts or tribunals and is on a removal pathway.

Health and welfare

Mr X was provided with treatment and counselling for a range of mental health issues including a history of torture and trauma.

Case status

Mr X was granted a Bridging visa on 19 October 2016 and released from immigration detention.
